3. A copy of the admission form.
4. Original and photocopies of all academic certificates.
5. Original and photocopy of the domicile certificate.
6. A service certificate (for candidates applying under the Children of GCUF Teaching and Non-Teaching Staff quota).
7. Original and photocopies of documentary evidence of Overseas Pakistani status (for candidates applying under the Overseas Pakistani quota).
8. Original and photocopies of documentary evidence of Minority Community status (for candidates applying under the Minority Community quota).
9. Original and photocopy of the Disability Certificate issued by the relevant authority (for candidates applying under the Persons with Disabilities quota).
10. Original and photocopies of the **Shahadat Certificate** issued by the relevant authority (for candidates applying under the Children of Martyrs quota).
11. Documentary evidence of previous enrollment and dropout (for readmission applicants).
12. Original nomination letter issued by the relevant authority (for candidates nominated by the Governments of Gilgit-Baltistan or Balochistan, or by Pakistan Army GHQ).

Note: Candidates who fail to produce the required original documents at the time of the interview may not be considered for the respective quota.
